We, the undersigned, duly qualified Unit Owners of the Brookside East of Tinley Park Condominium Association, an Illinois Not-for-Profit corporation ("Association"), in accordance with the provisions of Article XIX, Paragraph F the above-stated Declaration as filed in the office of the Recorder of Deeds of Will County, Illinois, as document number R2005202322, as from time to time amended, affecting the real estate described on Rider "A", attached hereto, hereby agree and consent to amend the aforesaid Declaration as follows (All additions in text are indicated by underline; all deletions in text are indicated by strike-through/interlineation):

The existing Article XVII, paragraph P shall be deleted in its entirety, as follows:

~~P. Leasing Any lease agreement between an Owner and a Lessee shall be in writing and be for a period of not less than one year for a minimum of one year and shall provide that the terms of such lease are subject to, and such lessee shall comply with, the provisions of this Declaration and the Articles of Incorporation, By laws and rules and regulations of the Association and that failure by the lessee to comply with the terms of such documents, rules and regulations shall be a default under said lease. Other than the foregoing, there is no restriction on the right of any Owner, including Declarant or Developer, to lease any Unit it owns.~~

The new paragraph and following language shall be inserted as new paragraph P of Article XVII, as follows:

"P Restriction of the Right Lease Units.

(P) It is the intention of the Board of Directors that all existing Unit Owners that have an oral or written leasehold with any person/entity may continue leasing their unit throughout the period of said owner's natural lifetime. To that end, all unit owners

that currently lease their units may continue to do so until all such owners of a unit transfer ownership of their unit or die, or until any corporate entity or trust in existence ceases (In which said owners hold an ownership interest in said corporate entity or trust). However, the right to lease units shall be contingent upon the Unit Owners providing a written lease to the Board and said lease term shall be for a minimum of one (1) year and shall be on file with the Board's Management Company. In the event any unit owner shall fail to promptly comply with the requirements of this paragraph (P), the Board shall be entitled to deny the unit owner the right to continue to lease their unit. Thereafter, the Board may file a circuit court action for eviction of the Lessees/occupants, as well as the recovery of attorney's fees and costs from the Lessees/occupants and the Unit Owner.

All other references to renting or leasing in the original Declaration, if any, filed in the office of the Recorder of Deeds of Will County, Illinois, as Document Number R2005202322, as from time to time amended, are hereby deleted."
